OUR PRACTICES IN ANGOLA

We present ourselves as a full service law firm in Angola. Notwithstanding, due to the specificities of local market there are some areas where we have been working more intensively. Those areas are:

Corporate & M&A

Advising on all legal aspects pertaining to Corporate and Securities Law in respect of Angola-Based entities and joint ventures, including the incorporation of these vehicles.

Joint Venture Agreements

Advising on Angolan local content requirements and the need to partner with local individuals or companies, negotiating such agreements for compliance with local law while safeguarding foreign investor's position.

Oil & Gas Regulatory

Advising on regulatory aspects of the Angolan Oil & Gas Exploration and Production Framework, notably by reference to the Petroleum Activities Law (10/04) and ancillary regulations.

Due to the specific characteristics of the local market, our practice in Mozambique has a greater focus in the following areas:

Foreign Investment

Preparation, presentation and negotiation of several foreign investment projects prior to the authority of investment promotion of Mozambique.

Corporate & Capital Markets

Advice on all legal aspects of corporate law and capital markets, particularly with regards to companies and joint ventures based in Mozambique; including the elaboration of equity and debt instruments as well as the corporate structure for complex and cross-border projects.
